

Privacy Policy - recruiting services (1)

Globalserve Consultants Ltd, as a legal person determines the purposes and means of processing of Personal Information we receive. This means that Globalserve is the “controller” of Personal Information we receive and process and we have and take responsibility in our capacity as a controller, up to the extent that the information is not processed by another controller.

“Personal Information” or “Personal Data” is information that identifies you as an individual or relates to an identifiable individual i.e. through which you may be identified. It always has to do with living people and does not concern legal entities such as companies. We always only collect what is necessary for the purposes defined below. Any use and/or disclosure and/or transfer of Personal Information is only done to the extent that it is necessary and proportionate to the purposes defined below.

We collect the below information based on the agreement between us and/or under the recruiting services agencies law and regulations and/or our legitimate interest to be able to provide the best possible employment opportunities to you.

The Personal Information we collect are the following:

- a) CV and any information contained therein;
- b) studies, academic titles, educational level;
- c) working experience and languages;
- d) any documents proving the above and/or of any information contained in the CV;
- e) ID and citizenship;
- f) specialization;
- g) the employment agreement and the type of employment agreement.
- h) any other type of information which you may choose to provide to us or we may obtain about you through third parties with whom we do business (e.g. our associates and/or agents and/or their personnel).

The collection of the above information, apart from the fact that it is necessary for the provision of our services on the basis of the agreement between us and the prospective Employee, it is a statutory requirement based on the law (126(I)/2012) and regulations (specifically 280/2012) on private recruiting services offices.

We collect and use Personal Information for the below purposes:

- a) to provide you with possible employment opportunities;
- b) to evaluate your suitability in relation to possible employment opportunities;
- c) to communicate with the candidate employees to arrange interviews;
- d) to make preparations for the entering into an employment contract (when applicable).

Your Personal Information may be shared with candidate employers in the intervals of the provision of recruiting services. The candidate employer might be located abroad, including outside the European Economic Area.

Personal Data in relation to Candidate Employees for the provision to them of recruiting services:

- 1,5 year following the receipt of the Personal Data; and
- 5 years following the employment of a successful Candidate Employee through our mediation.

You have the right to request from Globalserve Consultants Ltd the access to and rectification or erasure of personal data or restriction of processing concerning the data subject or to object to processing as well as the right to data portability, to lodge a complaint with a supervisory authority (Office of the Personal Data Commissioner in Cyprus).
